**TERMS AND CONDITIONS:-**

1. All the bidders shall have to deposit Rs. 5000.00 (Rs. Five thousand) only in shape of demand draft in favour of Managing Director, HPTDC, Shimla as EMD (refundable) before the auction starts.
2. The successful bidder shall be required to deposit 50% amount of the bid in shape of DD drawn in favour of MD HPTDC or cash at the time of auction and remaining amount shall have to be deposited after the acceptance of bid by the competent authority.
3. The above said dismantled building material is being offered for auction and the transportation of auctioned material shall be the responsibility of the successful bidder.

4. In case of any dispute relating to the sale of building material if arise, the decision of the auction committee (at the spot) will be final.
5. The successful bidders shall not be allowed to lift the material unless he or she has paid/deposited balance amount of the bid, GST and other taxes as applicable.
6. The under signed reserves the right to accept/reject any one or all bids without assigning any reason thereon. The successful bidder shall be liable to lift the material within fifteen days from the date of acceptance of bid by the competent authority.
