## **ORDER**

Whereas, Department of Tourism & Civil Aviation, HP has issued additional Standard Operating Procedures (SOPs) for opening of Tourism Units and for tourists coming by Air/by Train in the State vide order No.Tsm-F(4)-3/2020 dated 4<sup>th</sup> July, 2020 and Tsm-F(4)-3/2020-II dated 24-7-2020 respectively.

And Whereas, after considering the status of COVID-19 pandemic and the overall circumstances, the SOPs issued earlier are required to be modified to some extent.

Therefore, the undersigned in partial modification of SOPs issued earlier vide Order dated 4<sup>th</sup> July, 2020 and 24<sup>th</sup> July, 2020, hereby orders to issue amended **Standard Operating Procedures (SOPs) for tourists coming in the State** as per <u>Annexure-"A"</u> appended to this Order for information and strict compliance thereto of all concerned.

These Standard Operating Procedures (SOPs) shall come into force with immediate effect.

4	Protocol for handling suspected & COVID positive guests in a Tourism Unit	In case, a COVID positive guest is found/detected in a tourism unit, then that particular room where he/she was staying shall be sealed for 24 hours after deep cleaning. Further all places he/she has visited in the previous 48 hours shall also be deep cleaned.		
5	Precautions required to be taken for taxi Driver	The driver who is just dropping the guests will be exempted from quarantine (whether he is in a private vehicle)
